

CHANGE-OF-NAME AGREEMENT

CSRA LLC, a limited liability company duly organized and existing under the laws of Nevada, and the United States of America (Government), enter into this Agreement as of May 20, 2016.

(a) The parties agree to the following facts:

(1) The Government, represented by various Contracting Officers of the Department of Defense and other United States Government agencies, has entered into certain contracts and purchase orders with the CSC Government Solutions LLC, as shown in the attached list marked "Exhibit A" and incorporated in this Agreement by reference. The term "the Contracts," as used in this Agreement, means the above contracts and purchase orders and all other contracts and purchase orders, including all modifications, made by the Government and the Contractor before the effective date of this Agreement (whether or not performance and payment have been completed and releases executed if the Government or the Contractor has any remaining rights, duties, or obligations under these contracts and purchase orders).

(2) CSC Government Solutions LLC, by an amendment to its Articles of Organization, filed May 3, 2016 with an effective date of May 20, 2016, has changed its corporate name to CSRA LLC.

(3) This amendment accomplishes a change of corporate name only and all rights and obligations of the Government and of the Contractor under the Contracts are unaffected by this change.

(4) Documentary evidence of this change of corporate name has been filed with the Government.

(b) In consideration of these facts, the parties agree that—

(1) The Contracts covered by this Agreement are amended by substituting the name "CSRA LLC" for the name "CSC Government Solutions LLC" wherever it appears in the Contracts effective May 20, 2016; and


